On March 20, 2018, Tuolumne River Trust, American Whitewater, American River Touring Association, Inc., Sierra Mac River Trips, Inc., Central Sierra Environmental Resource Center, California Sportfishing Protection Alliance, Friends of the River, O.A.R.S. West Inc., and All Outdoors California Whitewater Rafting, Inc. (collectively, "Intervenor NGOs") filed Notice of Appearances and Notice of Intervention and Response to Modesto and Turlock Irrigation Districts (collectively, "Districts") request for trial-type hearing under Federal Power Act section 4(e) regarding the Department of Interior's Bureau of Land Management's ("BLM") preliminary mandatory conditions for the Don Pedro Hydroelectric Project (P-2299). Intervenor NGOs indicated their intent to subpoena witnesses under 43 C.F.R. § 45.47 for certain disputed issues but did not disclose the witnesses' names at the request of their government employers. Intervenor NGOs have obtained permission to make such disclosures, and now supplement their witness list to include the names, contact information, and qualifications of the remaining witnesses they intend to present at the hearing.

Intervenor NGOs intend to call Daniel Richardson to testify for disputed issues 4, 7, 12 and 15. His work address is 2 S. Green Street, Sonora CA 95370. His telephone number is 209-533-5511, and email address is drichardson@co.tuolumne.ca.us. He has been employed as the Tuolumne County Deputy County Administrator for 13 years. He oversees Information Technology, Facilities Management, Purchasing, Radios, and the Recreation Department for the County. He is expected to testify as to safety, communication, and maintenance issues at Ward's Ferry Bridge.

Intervenor NGOs intend to call Richard S. York Jr., R.C.E. to testify for disputed issues 6, 10, and 13. His work address is 2 South Green Street, Sonora, CA 95370. He currently is employed as Tuolumne County, Community Resource Agency, Deputy Director Roads, a position he has held since 1999. He started his career as a road reconnaissance technician for the U.S. Forest Service from 1973-1977. He was an Associate Civil Engineer at Frank Walter & Associates from 1978 to 1999. He is expected to testify as to road conditions, road safety, parking, and property lines at Ward's Ferry Bridge.

Intervenor NGOs intend to call Gabe Peterson to testify for disputed issues 7 and 12. His work address is 1015 Morningstar Drive, Sonora, CA 95370.
